Akelius issues bonds SEK 1,000 million

Akelius Residential Property AB (publ) has issued senior unsecured bonds to an amount of SEK 1,000 million.

The bonds mature in October 2023.
SEK 300 million have a fixed annual coupon of 1.875 percent and SEK 700 million have a variable interest rate of three months Stibor plus 1.3 percentage points.

The bonds will be listed on the Irish Stock Exchange.
The identification number for the bonds with fixed interest rate is XS1889043359.

The bonds with a variable interest rate have identification number XS1889043193.
