THE NATIONAL HELLENIC MUSEUM RELEASES MORE TRIAL OF SOCRATES TICKETS

Due to overwhelming demand: new venue, The Palmer House Hilton Hotel

CHICAGO, IL — The National Hellenic Museum releases more tickets for the most significant legal appeal in nearly **2,500 years - The Trial of Socrates**. To accommodate ticket demand, the event will take place in the Grand Ballroom at the Palmer House Hilton Hotel located at 17 E Monroe in the Grand ballroom on **Thursday, January 31, 2013** at 6 pm.

This is a once in a life time opportunity to watch some of the country's foremost legal minds as they re-try one of the biggest freedom of speech cases of all times. Judge Richard A. Posner presiding, William J. Bauer, former Chief Judge of the Court of Appeals, and Anna Demacopoulos, Circuit Court Judge, and a jury of distinguished citizens of Chicago, will decide the validity of these charges.
