

## Castellum appoints MD of Region West

**Mariette Hilmersson has been appointed as new Managing Director of Region West in Castellum. Mariette has most recently worked as Managing Director and CEO of Förvaltnings AB Framtiden and brings extensive experience to Castellum from several management positions in the real estate business. Förvaltnings AB Framtiden is a real estate group owned by the City of Gothenburg and responsible for all housing companies.**

As Managing Director, Mariette will manage Region West – that is operations mainly in Greater Gothenburg – with a real estate portfolio that amounts to approx. SEK 17 billion.

Castellum is one of the major listed real estate companies in Sweden. The fair value of the real estate portfolio amounts to approx. SEK 77 billion and comprises commercial properties for office, retail, warehouse and logistics with a total lettable area of approx. 4.4 million sq. m.

The real estate portfolio is owned and managed under the Castellum brand through a decentralized organization with strong and clear local presence in 20 cities from Copenhagen in the south to Sundsvall in the north.
