## Repurchase of shares in Synsam during August 25, 2025 – August 29, 2025 (week 35)

**Synsam AB (publ) (LEI code: 5493000TMEGW9DHNOQ70) ("Synsam" or the "Company") has during August 25, 2025, to August 29, 2025, repurchased in total 100,000 own shares (ISIN code: SE0016829709) as part of the share buy-back program initiated by the board of directors of Synsam in order to adjust the Company's capital structure.**

The repurchases form part of the share buy-back program of maximum MSEK 160 announced by Synsam on August 21, 2025, and which runs during the period from August 25, 2025, until February 27, 2026. The share buy-back program is being carried out in accordance with the EU Market Abuse Regulation (EU) No 596/2014 ("MAR") and the Commission Delegated Regulation (EU) 2016/1052 (the "Safe Harbour Regulation"). The purpose of the share buy-back program is to adjust the Company's capital structure by reducing its share capital.

Shares in Synsam has been repurchased in accordance with the following:

All repurchases have been carried out on Nasdaq Stockholm by DNB Carnegie Investment Bank AB (publ) on behalf of Synsam. Following the above listed repurchases, Synsam's holding of own shares as per August 29, 2025, amounts to 3,451,252 shares. The total number of outstanding shares in Synsam is 147,864,494.
