## **SaltX Technology Holding AB (publ) intends to carry out a directed new share issue of B-shares**

**SaltX Technology Holding AB (publ) ("SaltX" or the "Company") today announces its intention to carry out a directed new share issue of B-shares, generating approximately SEK 60 million from Swedish and international institutional investors (the "Directed New Share Issue"). The directed new share issue is primarily carried out to finance further product development.**

The Directed New Share Issue is intended to be carried out with deviation from the shareholders' preferential rights and based on the authorization given by the Annual General Meeting held on April 22, 2021. SaltX has engaged Pareto Securities AB ("**Pareto Securities**") to investigate the conditions for a new issue of shares through a so-called accelerated bookbuilding procedure.

The subscription price for the shares in the Directed New Share Issue is to be determined through an accelerated bookbuilding procedure, which will begin no earlier than 17:31 CEST today, May 17, 2021, and end before the commencement of trading on Nasdaq First North Premier Growth Market on May 18, 2021. The bookbuilding procedure may, at the discretion of the Company or Pareto Securities, close earlier or later and may be cancelled at any time.

The rationale for carrying out the Directed New Share Issue and for the deviation from the shareholders' preferential rights is to secure financing of the Company's strategy and progress, including product development, in a time- and cost-effective manner. The Board of Directors' assessment is that the subscription price in the Directed New Share Issue will be in accordance with market conditions since it will be determined through an accelerated bookbuilding procedure.

In connection with the Directed New Share Issue, the Company has undertaken, with customary exceptions, not to issue additional shares for a period of 360 calendar days after the announcement of the outcome of the Directed New Share Issue. Board members and senior executives, including the CEO and the CFO, have undertaken not to sell any shares in SaltX for a period of 90 calendar days after the announcement of the outcome of the Directed New Share Issue, with customary exceptions.

The Directed New Share Issue is subject to a resolution by the Board of Directors of SaltX to issue new shares based on the issue authorization given by the Extraordinary General Meeting on April 22, 2021, following the close of the bookbuilding procedure.
