WntResearch publishes prospectus due to the forthcoming rights issue of units

Wntresearch AB (“WntResearch” or the “Company”) has prepared a prospectus (the “Prospectus”) in connection with the Company's forthcoming rights issue of units, which was resolved upon and announced on March 17, 2021 (the “Rights Issue”). The Prospectus has today been approved and registered by the Swedish Financial Supervisory Authority (Sw. Finansinspektionen). The Prospectus is now available on the Company's website, www.wntresearch.com, and will be available on Mangold Fondkommission AB's website, www.mangold.se, and on the Swedish Financial Supervisory Authority's website, www.fi.se.

The Prospectus has been prepared in connection with the forthcoming Rights Issue and has today, March 30, 2021, been approved and registered with the Swedish Financial Supervisory Authority. The Prospectus, containing complete terms and conditions, as well as application forms and other information about the Rights Issue is available on the Company's website, www.wntresearch.com, and will be available on Mangold Fondkommission AB's website, www.mangold.se, from April 8, 2021. About WntResearch

WntResearch is a biotech company in oncology that develops new therapies intended to prevent the metastatic process. The company's research is focused on studying the endogenous protein WNT5A, which in scientific studies has shown to affect tumor cells' ability to move and spread in the body. WntResearch drug candidate Foxy-5 is a peptide that mimics the function of WNT5A and is intended to reduce the mobility and spread of cancer cells thus preventing metastases from occurring. Although current cancer treatment has become more effective, there are no effective ways to prevent the onset of metastases that cause about 90 percent of all cancer-related deaths. Foxy-5 has a unique mechanism of action and has shown a good safety profile with few side effects in two Phase I clinical trials. The safety

and efficacy of Foxy-5 are now being evaluated in the ongoing Phase 2 clinical trial NeoFox, in patients with stage II-III colon cancer.
