



## **SyntheticMR's rights issue has been registered – conversion of BTA into shares**

**SyntheticMR AB (publ) ("SyntheticMR" or the "Company") announces that the Company's rights issue of shares, the subscription period of which ended on 3 February 2026 (the "Rights Issue"), has today been registered with the Swedish Companies Registration Office. Paid subscribed shares ("BTA") will thereby be converted into shares. The last day of trading in BTA is 16 February 2026 and the record date is 18 February 2026. The new shares are expected to be booked into the respective securities account/VP account on 20 February 2026.**

The Rights Issue was carried out during the period 20 January 2026 – 3 February 2026 and provided the Company with approximately SEK 32.8 million, before issue-related costs. The Rights Issue has now been registered with the Swedish Companies Registration Office, and the last day of trading in BTA is 16 February 2026 and the record date is 18 February 2026. The shares are expected to be available in the respective VP account/securities account on 20 February 2026.
