WasteLog will be included as part of the company's own range and will thus be immediately exposed to the approximately 600 clinics in the USA that currently have Codonic's SLS system. The collaboration means that we properly accelerate our commercial activities in the North American market. This, combined with the fact that we have our own very experienced sales staff on the ground, makes me look forward to exciting growth in the USA."
