

## WULFF GROUP PLC: NOTIFICATION ACCORDING TO CHAPTER 9, SECTION 10 OF THE SECURITIES MARKET ACT

Wulff Group Plc has received a notification under Chapter 9, Section 5 of the Securities Markets Act from Ari Pikkarainen on April 9, 2021, according to which Ari Pikkarainen's shares in Wulff Group Plc's shares decreased below 10% due to sales of shares on April 9, 2021. According to the information Wulff Group Plc received from Ari Pikkarainen the holding decreased to 680 695 shares, which is 9.85% of the shares and votes of Wulff Group Plc. Wulff Group Plc has got one series of shares, in which one share has got one vote each. The total number of shares of Wulff Group Plc is 6 907 628.
