Altor Invest 10 AS ("**Altor**") has sold 16,299,438 shares in RVRC Holding AB (publ) ("**RevolutionRace**", or the "**Company**") through an accelerated book-building to Swedish and international institutional investors at a price of SEK 60 per share (the "**Share Sale**").

Following the Share Sale, Altor no longer holds any shares in the Company.

ABG Sundal Collier and DNB Carnegie acted as Joint Bookrunners in connection with the Share Sale.
