

Notification of Major Holdings in Catena Media plc

Catena Media plc (the "Company") hereby announces, that it has received a notification from Optimizer Invest Ltd, a Maltese company with its registered office in St. Julians, Malta ("Optimizer"), in relation to a disposal by Optimizer of voting rights in the Company on 21 December 2018 (the "Notification").

The Notification indicates that Optimizer, as of 21 December 2018, no longer holds any shares or voting rights in the Company.

The Company has been informed by Optimizer that the Notification is submitted to the Company following a reorganization of Optimizer's holdings as press released by Optimizer on 21 December 2018. As part of the reorganization, Optimizer's Catena Media shares were distributed to Optimizer's shareholders, who now own the shares directly.
