Brighter signs agreement to launch the diabetes solution Actiste in Indonesia.

Brighter has chosen Indosat Ooredoo in cooperation with Ericsson as partners for the launch of Actiste in Indonesia. The solution will be launched based on the Ericsson's DCP (Device Connection Platform) for Connectivity Management.

Diabetes is growing fast in the region and in 2015 about 10 million people live with the disease in Indonesia and another 5 million are undiagnosed, according to the International Diabetes Foundation. Actiste will be marketed and sold as a subscription service to both consumers and the healthcare sector. One key driver for Brighter's focus on Indonesia is that healthcare is a priority investment in both public and private sectors. In 2014 the government of Indonesia launched a national health plan that includes diabetes treatment, including medical devices such as Actiste and digital services.

"We are very pleased to take another step further in the launch of Actiste in the Southeast Asian market along with one of Indonesia's foremost mobile operators. Indosat Ooredoo, already heavily committed in the digitization of Indonesia, is a perfect partner for the launch of Actiste. Now we can intensify the work to help the millions of people living with diabetes that, on a daily basis, need to measure blood glucose and inject insulin. The Actiste subscription service will not only make daily routine simpler, it will also allow for better follow up and prioritization from the healthcare professionals, supported by The Benefit Loop. This is what the doctors are needing to dramatically improve the outcome of the treatment and reduce consequential damages such as foot amputations, dialysis, stroke, to mention a few, says Truls Sjöstedt, Brighter's CEO and founder.

"We are pleased that our strategic engagements with global/international OEM's is leading to business agreements for our operator partners offering DCP as a Service. Our partnership with Brighter and leading local telecom operator will enable an improved and more efficient healthcare sector in Indonesia, bringing the nation one step closer to becoming a truly Networked Society, in which individuals, in this case diabetes patients, are empowered to better manage their health and wellbeing.", says Thomas Jul, Head of Customer Unit Indonesia & Timor Leste at Ericsson.

The launch is scheduled for late 2017, following Actiste's CE-marking, launch in Sweden and local regulatory registration.




insulin, as well as automatically log and share information.
