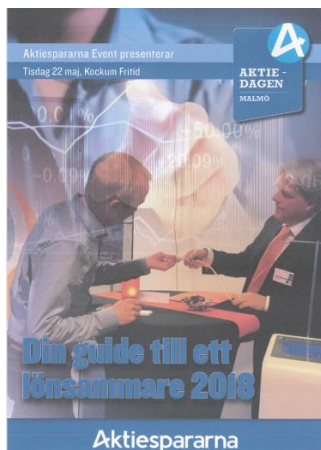
Dear shareholder,
