- The newly issued shares comprised 21 percent of the outstanding shares after the Offering.
- The Offering raised proceeds of approximately SEK 10.0 million and the over-allotment option raised proceeds of approximately SEK 2.5 million, in total SEK 12.5 million before transaction costs.
- Approximately 800 investors have been allotted shares in TalkPool.
- Trading on Nasdag First North Stockholm will commence on 24 May 2016 with the ticker "TALK".
- Day of settlement for the Offering is 23 May, 2016.
