The order was placed by a new customer in the strategic Ground Support Equipment segment: Vestergaard Company, a Danish, family-owned company, which manufactures vehicles adapted for the global GSE market. Vestergaard Company is a leading supplier of vehicles for various ground services required at airports.

Batteries based on lithium-ion technology are becoming more and more common in airport vehicles, since the aviation industry is among the many industries that must reduce its carbon dioxide emissions to achieve climate neutrality.
