Sotkamo Silver has agreed with the local construction company RPK Rakennus Kempainen Oy about the foundation of the concentrator plant and related civil works. The value of the delivery is about € 2,1 million. These works are included in the already decided € 8.5 million investments in the construction of the Silver Mine.
