## **SOTKAMO SILVER: THE FIRST CONCENTRATE DELIVERY TO THE SMELTER HAS BEEN DONE**

The first concentrate delivery to Rönnskär smelter has been carried out. The production of Silver Mine during 2019 is expected to be approximately 1,150,000 - 1,250,000 troy oz Silver, which is estimated to account for about 60-63 % of the total revenue.
