



ChromoGenics strengthens its management team

ChromoGenics is restructuring and strengthening its management team to accelerate the transformation to a profitable industrial company.

The company has filled two prioritized roles, and both roles will be part of the management team.

Linus Wetterlind has been named the head of sales and will start at ChromoGenics on February 1. He will lead the company's sales organization. Linus comes most recently from a position as sales manager at the world-leading glass producer Guardian Industries. He most recently held the role of manager of purchasing and production at ScandiDos, a medtech company that is listed on Nasdaq First North. Victor holds a master's degree from Uppsala University in engineering physics with a specialization in materials science.

The plastic film is easy to transport, so long shipments of bulky glass can be avoided. ChromoGenics also offers static glass, ConverLight® Static, and the ConverLight® Energy facade glass solution. ChromoGenics' stock was listed on Nasdaq First North Growth Market in 2017 and has supplied glass technology to several major real estate companies.
