## **Pihlajalinna's dental health services will be part of Hammas Hohde at the beginning of April**

**The sale of Pihlajalinna's dental health services to Hammas Hohde Oy has been completed today, 31 March 2023. The 16 clinics and approximately 200 dental health professionals will be part of Hohde from the beginning of April 2023. The divestment is part of the process of simplifying Pihlajalinna's business portfolio. In Pihlajalinna's public services, dental health services will continue to be provided by the company as before.**

"We are streamlining our business portfolio in private healthcare services and focusing on selected services, such as comprehensive surgical operations services. Dental health services will continue to be offered to customers in close partnership with Hohde. Also, the clinics to be transferred to Hohde will remain in our premises as before. In addition, Hohde's expertise and investments in dental health services will further improve the nationwide offering for our occupational healthcare customers, for example," says **Mikko Wirén**, interim CEO of Pihlajalinna.

"The transfer of Pihlajalinna's dental clinics to Hohde Group is an important step for us. Moving forward, we will have operations in 21 locations and in 33 clinics with approximately 500 professionals. We are now able to help our customers comprehensively across Finland, in line with our strategy," says **Ville Pesonen**, CEO of Hammas Hohde.

The parties have agreed not to disclose the transaction price.
