Pihlajalinna Plc: Flagging announcement in accordance with Chapter 9, Section 10 of the Securities Markets Act

Pihlajalinna Plc has on 9 April 2024 received a notification under Chapter 9, Section 5 of the Securities Market Act, according to which the holding of LähiTapiola Keskinäinen Henkivakuutusyhtiö in Pihlajalinna Plc's shares and votes has risen above 10 per cent on 8 April 2024. The holding of LähiTapiola Keskinäinen Henkivakuutusyhtiö has increased to 10.15 per cent and 2,295,656 shares of the total of Pihlajalinna's shares and votes.

Pihlajalinna has a total of 22,620,135 shares. Each share entitles its holder to one (1) vote.
