Conversion of shares

According to Essity's articles of association, owners of Class A shares have the right to have such shares converted to Class B shares. Conversion reduces the total number of votes in the company. When such a conversion has occurred, the company is obligated by law to disclose any such changes in this manner.

In August, at the request of shareholders, 350,200 Class A shares were converted to Class B shares. The total number of votes in the company thereafter amounts to 1,174,812,540.

The total number of registered shares in the company amounts to 681,945,171 of which 54,763,041 are Class A shares and 627,182,130 are Class B shares.
