Bublar Group's acquisition of Goodbye Kansas completed. Offer period extended to June 17th

Bublar Group AB's (publ) acquisition of Goodbye Kansas is now formally completed and 96,64 percent of shareholders and 93 percent of creditors have accepted the offer. Bublar Group's Board of Directors has decided to extend the offer period to June 17th. Goodbye Kansas will be included in the reporting for Bublar's interim report for Q2 as a subsidiary of Bublar Group.

Goodbye Kansas has a strong reputation and has leading international companies in film, gaming and streaming as customers. The deal provides the opportunity to create a world-leading player in XR technology and visualization.
