## **Nomination committee appointed for PowerCell's Annual General Meeting 2021**

**The annual general meeting decided on April 24, 2020, to appoint a nomination committee for [PowerCell Sweden AB \(publ\)](#), consisting of one representative each from the three largest shareholders as of July 30, 2020, plus one representative from the board of PowerCell. These representatives have now been appointed.**

The three largest shareholders in PowerCell as of 30 July 2020 who, upon request, also expressed their interest in participating in the nomination committee, were: Robert Bosch GmbH, Fouriertransform and Livförsäkringsbolaget Skandia.
