## Nomination Committee for the Saab Annual General Meeting 2020

The members of the Nomination Committee for Saab have now been appointed based on the shareholder structure on 31 August 2019, in accordance with a resolution by the Saab Annual General Meeting.

The Nomination Committee shall, according to the Nomination Committee process adopted by the Annual General Meeting, consist of one representative from each of the four shareholders or group of shareholders with the largest numbers of votes, who wish to appoint a representative. In addition, the Chairman of the Board of Directors shall also be a member of the Nomination Committee.

The Nomination Committee is assigned to prepare proposals regarding Chairman of the Annual General Meeting, Board of Directors, Chairman of the Board of Directors, as well as Board remuneration and fee to the Auditor.

The Nomination Committee represents approximately 57 percent of the total voting rights of Saab AB based on the ownership structure as of August 31, 2019.

The Annual General Meeting of Saab AB will be held on Wednesday, 1 April 2020 in Stockholm.
