



Adapteo Plc: 4,442,025 new shares registered with the trade register

Adapteo Plc ("Adapteo") announced 10 December 2020 the result of the offering of new shares (the "Placing Shares") in a private placement to institutional and other qualified investors (the "Placing"). In the Placing, Adapteo issued a total of 4,442,025 Placing Shares. The Placing Shares have today been registered with the trade register maintained by the Finnish Patent and Registration Office.

Following the registration of the Placing Shares, the total number of registered shares in the Company is 49,124,722. The Placing Shares will be issued in the book-entry system (ISIN code F14000383898) on or about 14 December 2020. After this, and registration on the investors' book-entry accounts, they will confer shareholder rights in Adapteo. The Placing Shares are expected to be ready for delivery to the investors against payment through Euroclear Sweden AB on or about 15 December 2020.

Trading in the Placing Shares is expected to commence on the official list of Nasdaq Stockholm on or about 15 December 2020.
