Catena intends to carry out a directed share issue

Catena AB (publ) ("Catena" or the "Company") intends to carry out a directed issue of up to 3 million new shares (the "Share Issue"), to Swedish and international institutional investors, through an accelerated book building procedure and has appointed ABG Sundal Collier and Kempen & Co as Joint Bookrunners in connection with the Share Issue.

The subscription price and final number of new shares will be determined by way of an accelerated book building procedure, which will commence immediately after publication of this announcement and end before the commencement of trading on Nasdaq Stockholm on April 1, 2021. Catena will publish the results of the Share Issue when the book building procedure is finished. The book building procedure may, at the discretion of the Company, close earlier or later or, may be cancelled at any time.

The Share Issue is subject to a resolution by the board of directors of Catena, which, alongside pricing and allocations, is expected to occur before trading starts on Nasdaq Stockholm at 09.00 a.m. on April 1, 2021. The potential Share Issue will be executed in accordance with the authorisation granted by the annual general meeting on April 29, 2020.

The Company continues to notice a strong demand for modern and efficient logistics premises. The Share Issue is undertaken to continue growing by investments in project development and property acquisitions, and to maintain the Company's stable capital structure.

In connection with the Share Issue, the Company has agreed, with customary exceptions, not to issue additional shares for a period of 180 calendar days after the settlement date. In addition, various board members and management team members have agreed, with customary exceptions, not to sell any existing shares in Catena for a period of 180 calendar days after the settlement date.
