

## **Everfuel Achieves RFNBO Certification – A Major Milestone for Green Hydrogen in Europe**

Herning, Denmark, 3 September 2025 – Everfuel is pleased to announce that we have achieved RFNBO certification officially recognising that our hydrogen production facility, HySynergy, produces green hydrogen under the EU's Renewable Fuels of Non-Biological Origin (RFNBO) framework.

Everfuel is now a Certified RFNBO Producer, setting a new benchmark for sustainable energy in Denmark and across Europe.

The certification is the gold standard for green hydrogen under the EU's RED II and RED III directives. It confirms that Everfuel's hydrogen production from HySynergy meets the strict environmental and traceability criteria required to contribute to the EU's binding renewable energy targets. Some key properties associated with Everfuel's RFNBO certification are:

- >99% emissions reduction compared to fossil fuels'
- · Certified under ISCC, ensuring full compliance with EU sustainability and GHG reduction criteria
- Strategic alignment with Fit-for-55, RePowerEU, and the Hydrogen Backbone initiative
- New market access in Denmark, Germany, and Northern Europe for certified hydrogen supply
- Enabling RFNBO production combined with opportunity to engage in the power balancing market

RFNBO certification not only validates our ambition of producing green hydrogen at scale — it also opens the door to long-term partnerships in industry and transport. The certification process, completed through ISCC, reflects Everfuel's commitment to pioneer the green hydrogen industry.
