Change in the total number of shares and votes in SLP

As of 29 May 2026, the total number of shares in Swedish Logistic Property AB ("SLP") amounts to 282,116,855 shares, divided into 38,715,160 shares of series A and 243,401,695 shares of series B. The total number of votes in SLP as of 29 May 2026 amounts to 436,977,495.

The increase in the number of shares and votes in SLP is due to that warrants of series 2023/2026, all of which were acquired during 2023, has been fully exercised, resulting in an issue of 1,912,349 B-shares.
