## Nordic Shield Group secures strategic order worth SEK 256 million – Astor Group's associated company strengthens its position in infrastructure

Scandinavian Astor Group's ("Astor Group" or the "Company") associated company in the field of security-classified structures, Nordic Shield Group AB ("NSG"), has received an order worth approximately SEK 256 million through its wholly owned subsidiary NEZ AB ("NEZ"). The order is for technical premises for a company in the Western world. The revenue will be recognized in the report for the fourth quarter of 2025 and will be reported on an ongoing basis with preliminary final delivery in the fourth quarter of 2026.

The current project involves the development and construction of security-classified technical facilities with high standards for both physical protection and technical infrastructure. The customer is a Western company in the IT industry. NEZ has extensive experience in this area and will carry out the project in close collaboration with the customer.

The order is one of the largest in NSG's history and underscores the company's position as a strategic partner for critical infrastructure operators and international companies with high security requirements.

NSG is an associated company within Astor Group's Astor Protect business area. Through Astor Group's ownership stake in NSG, the transaction is expected to generate a positive contribution to the Group's earnings from the fourth quarter of 2025 and on an ongoing basis until the preliminary final delivery in the fourth quarter of 2026.

"An order of this magnitude for critical infrastructure protection demonstrates the trust that Nordic Shield Group has built up. We see a growing need for this type of infrastructure protection in both the public and private sectors — and through Astor Protect, we are creating value in this strategic segment", says Mattias Hjorth, CEO of Astor Group.

Due to the nature of the industry and circumstances concerning customers and national security interests, no further information about this order or customer will be disclosed.
