## **Transaction in own shares: purchase of own shares to be held in treasury**

The Company announces that it has today purchased 9,073 of its Ordinary Shares at an average price of 618.55 pence per share to be held in treasury.

Following settlement of this purchase on 24 June 2026 the issued share capital of the Company will be 90,725,270 Ordinary Shares, excluding 27,203,668 shares which are held in treasury. Shares held in treasury do not carry any voting rights; 23.07% of the Company's total issued share capital (117,928,938 Ordinary Shares, including treasury shares) will be held in treasury following settlement.

For reporting purposes under the FCA's Disclosure Guidance and Transparency Rules the market should exclude any shares held in treasury and should use the figure of 90,725,270 following settlement when determining if they are required to notify their interest in, or a change to their interest in the Company.
