The resultant total number of Ordinary Shares held in Treasury by the Company is 25,391,167. The number of Ordinary Shares that the Company has in issue, less the total number of Ordinary Shares held by the Company in Treasury following this sale, is 69,970,138. With effect from 17 September 2026 the total number of voting rights of the Company will be 69,970,138. This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in the Company, under the Disclosure Guidance and Transparency Rules.
