In Selected Car Collection, Anders Bilidt will work closely with Flemming Rechnitzer, who has been involved since the collection began in 1990 and, as Commercial Director, is responsible for the operation and development of the collection's facilities and events. Since the opening

in 2017, more than 1,000 events and functions have been held for both Danish and international companies.

Anders Bilidt will have his day-to-day base in Middelfart, both at Selected Car Group's car showrooms and at the headquarters of co-owner Selfinvest in Turbinehallen.
