November: Monthly statistics

The number of customers at Avanza has during 2018 increased by 119,000, amounting to 9,200 new customers in November. This resulted in 829,700 customers at the end of the month. Net inflow in November was SEK 2,730*m, amounting to SEK 26,700*m during 2018.

In November, the Swedish Savings Barometer was published with statistics for the third quarter 2018. Avanza's share of the savings market increased to 4.0 per cent at the end of the quarter and the share of net inflow was 16.5 per cent. Rolling 12M net inflow amounted to 11.0 per cent, which exceeds the target of at least 10 per cent.

Avanza's market share of premiums paid for occupational pension insurance was 4.8 per cent during the period October 2017 – September 2018 according to statistics from Insurance Sweden. This was an increase from 3.9 per cent during the corresponding period the previous year.
