Dooba Investments Limited Completed Sale of Shares in ALM Equity AB

Dooba Investments Limited (publ) ("Dooba" or the "Company", and together with Dooba Holdings Limited and its subsidiaries, the "Group"), a property investor and developer in the United Kingdom, has today sold 1,019,755 shares in ALM Equity AB (publ) ("**ALM**"), corresponding to c. 3.07% of the outstanding shares in ALM (the "**Placement**"). The shares were sold to a professional investor through a private bidding procedure executed by ABG Sundal Collier and Pareto Securities AB. Following the Placement, Dooba retains no ownership in ALM.

ABG Sundal Collier and Pareto Securities AB acted as joint bookrunners (together, the "Joint Bookrunners") in connection with the Placement.
