## **Completed sale of shares in Scandic Hotels Group**

Eiendomsspar AS ("Eiendomsspar") has today, 18 November 2025, sold 14,705,883 shares in Scandic Hotels Group AB ("Scandic" or the "Company"), corresponding to approximately 6.8% of the shares in the Company (the "Placement"). The shares were sold to a select number of institutional investors through a private bidding procedure executed by ABG Sundal Collier AB ("ABG Sundal Collier").

Following the Placement, Eiendomsspar retains an ownership corresponding to approximately 8.2% of the shares in the Company. Eiendomsspar has agreed to a customary lock-up agreement for 90 days with respect to its remaining shares in Scandic.

ABG Sundal Collier acted as sole global coordinator and bookrunner in connection with the Placement.
