# Rejlers acquires DynaMate's consultancy division

**Through the agreement with Scania-owned DynaMate, Rejlers Sweden is adding to its expertise within HVAC and other key areas and further strengthening the services it offers within safety. In total, 31 employees will transfer to Rejlers' offices in Luleå, Stockholm, Borlänge and Oskarshamn with effect from 1 April.**

DynaMate, a Scania subsidiary, has actively been searching for a suitable buyer for its consultancy division. Rejlers has worked with DynaMate on a number of projects in Luleå and elsewhere, and both companies are very familiar with each other's operations.

"The consultancy division of DynaMate, which is set to become part of Rejlers, strengthens and further develops our services within both the industrial and construction sectors. The expertise within HVAC and machine and electrical safety in particular will be a welcome addition," says Jonas Thimberg, CEO of Rejlers Sweden.

"It is a very positive development that the business is set to be transferred to Rejlers, which can now continue to develop the business and provide leading technology consultancy services in the industrial sector," says Pär Holmgren, CEO of DynaMate AB.

Rejlers has worked with the Scania Group for many years and signed a framework agreement as Preferred Supplier within the industrial segment a year ago. Among other things, the agreement covers production development, product development, design, programming and motor and function testing. It is a partnership which Rejlers hopes will be developed further through the acquisition of the consultancy division of DynaMate.

## Facts about the acquisition

Rejlers is carrying out an 'assets and liabilities acquisition', where the 31 employees will transfer to Rejlers. These employees are dispersed across the country, being based in Luleå (11 people), Stockholm (17 people), Falun (two people) and Oskarshamn (one person).
