Royal Bank of Canada has agreed to issue EUR100,000,000 0.638 per cent. Covered Bonds due October 21, 2041, Series CB65 (the "**Covered Bonds**") pursuant to the €60,000,000,000 Global Covered Bond Programme of Royal Bank of Canada, unconditionally and irrevocably guaranteed as to payments by RBC Covered Bond Guarantor Limited Partnership (the "**Programme**").
