Royal Bank of Canada today issued EUR 1,000,000,000 Fixed to Floating Rate Callable Green Senior Notes due June 2030, Series 78775 (the "**2030 Notes**") and EUR 750,000,000 Fixed to Floating Rate Callable Senior Notes due August 2034, Series 78776 (the "**2034 Notes**" and, together with the 2030 Notes, the "**Notes**") pursuant to its Programme for the Issuance of Securities (the "**Programme**").

The following documents constitute the final terms dated June 11, 2026 in respect of the 2030 Notes and the final terms dated June 11, 2026 in respect of the 2034 Notes (collectively, the "**Final Terms**") relating to the admission to trading of the Notes for purpose of Article 8 of Regulation (EU) 2017/1129 and as it forms part of domestic law of the United Kingdom by virtue of the European Union (Withdrawal) Act 2018, as amended and must be read in conjunction with the Prospectus dated July 9, 2025, as supplemented by the 1st Supplementary Notes Base Prospectus dated August 28, 2025, the 2nd Supplementary Notes Base Prospectus dated December 10, 2025, the 3rd Supplementary Notes Base Prospectus dated February 27, 2026 and the 4th Supplementary Notes Base Prospectus dated May 29, 2026 relating to the Programme (together, the "**Prospectus**"). Full information on Royal Bank of Canada and the offer of the Notes is only available on the basis of the combination of the Final Terms and the Prospectus.
