The Association of MBAs (AMBA) is an international independent organisation that accredits postgraduate business programmes at business schools worldwide. AMBA accreditation defines a global standard for MBA programmes and only 207 business schools have thus far received AMBA accreditation, which equals less than five percent of all business schools in the world.

The assessment is based on the quality of the education, curricula and interaction with the participants. AMBA accreditation guarantees that the programmes are of a high standard and reflect current trends and innovations within postgraduate business programmes.

The Gothenburg Executive MBA programme is a part-time international management programme over 21 months, directed towards managers with at least three years' managerial experience.
