COMPLETION OF UIE'S SHARE BUY-BACK PROGRAMME

On 26 November 2025, UIE initiated two parallel share buy-back programmes: a 'Safe Harbour' programme and a 'Block Trade' programme. Both programmes were initiated with the intention of acquiring up to 645,000 shares, or for a total maximum consideration of DKK 245 million, before the end of 2026, cf. Company Announcement No. 10/2025.

The "Safe Harbour" programme was conducted in accordance with the European Commission's Regulation No. 596/2014 of 16 April 2014 (the "Market Abuse Regulation"), as well as the Commission's delegated regulation (EU) 2016/1052 of 8 March 2016 (the "Safe Harbour Regulation").

The two parallel share buy-back programmes were initiated on 26 November 2025 and were completed on 5 February 2026.
