Vestas secures 73 MW order in Poland

Vestas has received a 73 MW order from PAK-Polska Czysta Energia sp. z o.o., for the Czluchow wind project in Northern Poland. This order marks Vestas' first collaboration with PAK-Polska Czysta Energia sp. z o.o., a subsidiary of ZEPAK S.A., and with the towers being produced locally, Vestas further proves its commitment to creating value and jobs in Poland.

The order includes the supply, installation, and commissioning of 33 V110-2.2 MW turbines installed at a hub height of 120m. Vestas will also service the turbines under a 15-year Active Output Management 5000 (AOM 5000) service agreement.

"We are delighted to build a new partnership with PAK-Polska Czysta Energia sp. z o.o., as we continue to expand our services in Poland," said William Gaillard, Vice President for Vestas Sales East & BD. "The Czluchow project further proves Vestas' commitment to create value across the supply chain in Poland, as all towers will be produced locally. PAK-Polska Czysta Energia sp. z o.o. has also entrusted us with a 15-year full-scope service agreement which will further build out our service footprint in the region for the long-term."

"We are happy to be able to develop our presence in the renewable energy sector with help of such a reputable turbine supplier as Vestas. Building the Czluchow project is just the beginning of a long-term cooperation and we are most certainly looking forward to it," said Andrzej Janiszowski, Chief Strategy Officer for ZEPAK S.A.

Deliveries and installation at the Czluchow wind project are expected to begin in the third quarter of 2023, while commissioning is planned for the first quarter of 2024.
