

(3Q 13 in brackets)

- Operating revenues were NOK 3 411 million (NOK 2 648 million)
- Operating result before depreciation (EBITDA) was NOK 1 213 million (NOK 1 155 million)
- Operating result (EBIT) was NOK 190 million (NOK 597 million)
- Net result after tax was NOK - 38 million (NOK 494 million)
- Earnings per share were NOK 0.8 (NOK 6.5)



Fred. Olsen Energy – Operating worldwide







Renewable energy - Overview

- Total production capacity of 485.7 MW
 - Six operating wind farms in Scotland (414.4 MW)
 - One operating wind farm in Norway (71.3 MW)
- Construction:
 - Mid Hill II (18.4 MW) in Scotland. The construction is ongoing and is expected to be ready for operation 4Q14
 - Fäbodliden (78 MW) in Sweden. The construction has commenced with expected completion in 1Q16
- Consented and development:
 - 726 MW consented onshore in Scotland, Sweden and Norway
 - Approx. 500 MW consented offshore Ireland
 - Development pipeline of 700 – 1 280 MW onshore in Norway, Sweden and UK
 - Approx. 500 MW under development offshore Ireland

Renewable energy - Projects in the UK and Ireland




Renewable energy - Projects in Scandinavia

Shipping / Offshore wind - Overview

■ Fred. Olsen Windcarrier


- Two transport and installation vessel for offshore wind turbines; "Brave Tern" (2012) and "Bold Tern" (2013)
 - Contracts:
 - Trial Installation Project for Universal Foundation commenced end August and was completed early October 2014 with Brave Tern.
 - Commissioning support work at the Global Tech I wind farm for Global Tech I Offshore Wind GmbH in the German exclusive economic zone (EEZ) commencing October 2014 with Brave Tern. Estimated completion end 2014.
 - Installation work of 80 turbines at the "Butendiek" offshore wind power plant off Germany's North Sea coast for Siemens AG. Estimated duration 250 days, commenced in September 2014 with Bold Tern.
 - Installation work of 5 large 6MW Alstom wind turbines offshore of Rhode Island, United States. Commencing 2Q 2016.
 - Fleet of eight crew vessels. Currently employed in the UK, Germany and Denmark.
 - 51% ownership of Global Wind Service A/S, Denmark, an international supplier of qualified and skilled technicians to the global wind turbine industry with approximately 500 employees working world-wide.

■ Universal Foundation

- 82% ownership of Universal Foundation A/S, Denmark, which has developed the design of the foundation ("The Bucket Foundation") for offshore wind turbines. Installed two complete meteorological masts including foundations offshore UK.
- In October 2014 completed the Carbon Trust Trial Installation Project on Dogger Bank, Dudgeon and Horn Sea in the UK North Sea sector proving the installation and retrieval ability of the Universal Foundation. Project sponsored by Statoil, Statkraft, Dong, Eon, Carbon Trust and Universal Foundation .







Other investments - Overview

NHST Media Group AS (54.0%)

- Comprising four main business segments; Dagens Næringsliv, Digital & Nordic (New Media, Europower, TDN), Global (Tradewinds, Upstream, Intrafish and Recharge) and Nautical Charts
