# Audientes A/S announces sole distributor agreement in India with a minimum of DKK 4.8m in revenue committed for the first 12 months and expectations for rapid growth thereafter

Audientes A/S and <u>earKART India</u>, a rapidly growing hearing aid marketing and sales company, today announce an exclusive distributor agreement for the sales and marketing of Audientes' products in India, with a minimum of DKK 4.8m in revenue committed for the first 12 months, and expectations for multiplying growth in the coming years. A payment of DKK 150,000 is made upfront adding up to a minimum of DKK 1.0m in total by August 2023.

Starting this month, earKART India assumes general channel responsibility for Audientes' products in India, and will integrate Audientes' existing partner and distributor network with theirs. Audientes will remain responsible for online and in-store dealer training and education, end-user support and product warranty matters. In certain cases, Audientes will distribute directly to specific partners or organizations.

Working with its extensive dealer network of more than 1,200 nationwide, which is the largest hearing clinic dealer network in India, earKART has developed a scaleable and comprehensive lead generation engine currently generating approximately 2,000 client leads per month. Audientes' distribution network today encompasses 80+ partners with 500+ points of sale outlets combined, and will be integrated with that of earKART.

"This deal is a game changer for Audientes. It enables us to advance the sales and marketing of Ven in India with a strategic agreement now in place with earKART for exponential year-on-year growth. earKART has the experience, network and resources to really push Ven out into the hands of consumers – both offline and online. earKART already imports hearing aids and also manufactures hearing aids in India for government tenders, with a team that has deep knowledge of the regulatory environment there. As part of this agreement, we will collaborate to achieve future product approvals and to navigate the regulatory landscape in India for existing and future Audientes products", comments Audientes A/S CEO, Steen Thygesen and continues: "I am very excited to enter into this agreement with earKART and look forward to further grow the market presence of Audientes self-fitting hearing aids initially in India with expansion to Bangladesh, Sri Lanka and Nepal in the next years",
