## Overview

BH Macro Limited ("BHM") is a closed-ended investment company, registered and incorporated in Guernsey on 17 January 2007 (Registration Number: 46235). BHM invests all of its assets (net of short-term working capital) in the ordinary shares of Brevan Howard Master Fund Limited ("BHMF" or the "Fund"). BHM was admitted to the Official List of the UK Listing Authority and to trading on the Main Market of the London Stock Exchange on 14 March 2007.

**Rates:** interest rates markets **FX:** FX forwards and options

**Commodity:** futures & options on commodities including mining indices

**Credit:** corporate and asset-backed indices, bonds and CDS

**Equity:** equity markets including indices and other derivatives

**Digital Assets:** cryptocurrencies including derivatives

**Discount Management:** buyback activity or sales of shares

Total Capital exceeds AUM, accounting for gearing. Core BHMF Trader Allocations excludes Risk Overlay Strategies ("non-core books"). Risk Overlay Strategies are temporary tactical books that will open/close based on the aggregation of risk factors across the fund as well as investment opportunities at the time. As such the Top 3/5/10 calculation for capital allocation and VaR purposes excludes Risk Overlay Strategies from the numerator but includes them in the denominator. ## Performance Overview

Gains across interest rates, FX and to a lesser extent commodity and equity trading. Interest rate gains stemmed primarily from directional and curve trading of US, UK and BRL with additional smaller winners and losers. Interest rate volatility detracted over the month. FX gains came from EUR and EM currency pairs, with some  $offsetting\ losses\ from\ JPY\ amongst\ others.\ Commodity\ gains\ came\ mostly\ from\ oil\ while\ equity\ gains\ came\ from\ the\ US.$
