## Overview

BH Macro Limited ("BHM") is a closed-ended investment company, registered and incorporated in Guernsey on 17 January 2007 (Registration Number: 46235). BHM invests all of its assets (net of short-term working capital) in the ordinary shares of Brevan Howard Master Fund Limited ("BHMF" or the "Fund"). BHM was admitted to the Official List of the UK Listing Authority and to trading on the Main Market of the London Stock Exchange on 14 March 2007.

**Methodology**

Attribution by asset class is produced at the instrument level, with adjustments made based on risk estimates. The asset classes are categorised as follows:

**Rates:** interest rates markets

**FX:** FX forwards and options

**Commodity:** futures & options on commodities including mining indices

**Credit:** corporate and asset-backed indices, bonds and CDS

**Equity:** equity markets including indices and other derivatives

**Digital Assets:** cryptocurrencies including derivatives

**Discount Management:** buyback activity or sales of shares

As at 31 March 2026, the number of core BHMF traders managing directly or indirectly more than 10% of BHMF's total allocated trading capital<sup>3</sup> = 4.

**1.** The top 3, 5 and 10 core traders are shown by their Adjusted Capital allocation. Adjusted Capital applies weightings to the traders' nominal capital in order to normalise the data to a consistent level of potential severe downside. Total Capital exceeds AUM, accounting for gearing. Core BHMF Trader Allocations excludes Risk Overlay Strategies ("non-core books"). Risk Overlay Strategies are temporary tactical books that will open/close based on the aggregation of risk factors across the fund as well as investment opportunities at the time. As such the Top 3/5/10 calculation for capital allocation and VaR purposes excludes Risk Overlay Strategies from the numerator but includes them in the denominator. Approximately 15% of total BHMF capital (including non-core books) has been allocated to Risk Overlay Strategies. **2.** Calculated using historical simulation based on a 1 day, 95% confidence interval. ## Performance Overview

Losses for the month were primarily driven by interest rate and equity trading, with additional modest losses from FX, commodities, and credit. Within rates, directional and curve positions across European, Antipodean, and Asian markets detracted, partially offset by gains from volatility strategies. Equity losses predominantly stemmed from directional exposure to Asian indices as well as tactical US index trading. FX losses were driven by Asian currencies, partially offset by gains from European directional and volatility strategies. Commodity losses were concentrated in precious metals, while credit losses arose from corporate credit index hedges.
