BH Macro Limited ("BHM") is a closed-ended investment company, registered and incorporated in Guernsey on 17 January 2007 (Registration Number: 46235). BHM invests all of its assets (net of short-term working capital) in the ordinary shares of Brevan Howard Master Fund Limited ("BHMF" or the "Fund"). BHM was admitted to the Official List of the UK Listing Authority and to trading on the Main Market of the London Stock Exchange on 14 March 2007.

Performance Overview

Equity and FX trading were the primary drivers of losses during the month, with additional modest detractions from commodities and directional digital asset trading. Within equities, losses were driven primarily by directional US positions, while in FX, losses stemmed from directional Asian currency positions. Commodity losses were attributable to precious metals. These losses were partially offset by modest gains in interest rates, generated across both DM and EM directional and curve positions.
