BH Macro Limited ("BHM") is a closed-ended investment company, registered and incorporated in Guernsey on 17 January 2007 (Registration Number: 46235). BHM invests all of its assets (net of short-term working capital) in the ordinary shares of Brevan Howard Master Fund Limited ("BHMF" or the "Fund"). BHM was admitted to the Official List of the UK Listing Authority and to trading on the Main Market of the London Stock Exchange on 14 March 2007.

Performance Overview

Commodity trading was the primary driver of gains during the month, driven mainly by gains in precious metals. Equity trading was a further positive contributor, led by US positions with a smaller contribution from Asia, partly offset by tactical European positions. Digital assets also added positively. These gains were partially offset by losses in FX, mainly on yen positions, with a small gain in EM currencies. Interest rate trading was a modest additional detractor, as losses on US rate volatility and on EUR and other G10 directional positions outweighed gains in US rates. Credit also detracted, on corporate credit index positions.
