Royal Bank of Canada today issued EUR30,000,000 3.5129 per cent. Covered Bonds due March 22, 2046, Series CB104 (the "**Covered Bonds**") pursuant to the €75,000,000,000 Global Covered Bond Programme of Royal Bank of Canada, unconditionally and irrevocably guaranteed as to payments by RBC Covered Bond Guarantor Limited Partnership (the "**Programme**").

The following document constitutes the final terms dated March 19, 2026 (the "**Final Terms**") relating to the issue of the Covered Bonds for purpose of Article 8 of Regulation (EU) 2017/1129 and as it forms part of domestic law by virtue of the European Union (Withdrawal) Act 2018 (EUWA) and must be read in conjunction with the Prospectus dated July 9, 2025, as supplemented by the 1st Supplementary Prospectus dated August 28, 2025, the 2nd Supplementary Prospectus dated December 19, 2025 and the 3rd Supplementary Prospectus dated February 27, 2026, relating to the Programme (together, the "**Prospectus**"). Full information on Royal Bank of Canada and the offer of the Covered Bonds is only available on the basis of the combination of the Final Terms and the Prospectus.
